The deadline for submittal of your application is Aug 6, 2010 and there are no fees or other costs to apply. Just send Rick Stockstill your entry form per the attached document and you will be considered.

I hope many of you will take advantage of this opportunity and perhaps join us this year for the great skeet shooting and good times that is the NSSA World Shoot.

Three (3) winners will be randomly drawn from all valid entries received on or before August 6, 2010 for each State and Zone in order to have back-up names identified in the event that the first or second winner is unable to attend the 2010 World Shoot.

Winners will have 7 calendar days from notification to confirm with the NSSA Director at NSSA HQ of their intention to attend or decline; if they are unable to attend, the next winner in line will be contacted.
